

Terms of Use – Terms of Service

1. Your Acceptance

A. By using and/or visiting this website, collectively, including all Content available through TheFlyPod.com (the "Website"), you signify your agreement to these terms and conditions (the "Terms of Service"). If you do not agree with these terms, please do not use this Website.
